Limited Warranty for Premium Residential Aluminum Doors

Hörmann residential aluminum doors, when installed for residential use are warranted against oxidation or corrosion of the garage door sections resulting from the exposure to normal environmental conditions such as rain, ice, snow and sunlight for as long as you own your home, subject to the below schedule. Minor surface variations are not considered defects.

FINISHES: All painted or anodized door finishes provided by Hörmann are warranted for as long as you own your home. Color variations of anodized finishes are inherent due to material lots, environmental, chemical and equipment variations and not considered a defect. - •Five Years (5) Complete replacement of finished door sections
- •Ten Years (10) *50% discount off finished replacement door sections
- •Twenty Years (20) *25% discount off finished replacement door sections
- •Lifetime *10% discount off finished replacement door sections
- *Discounts refer to manufacturer's current wholesale price of factory finished door sections and do not include aftermarket finishes.

Upon inspection, Hörmann's authorized factory representative will solely determine the severity and extent of any alleged manufacturing defect. Hörmann will not be responsible for any packaging, shipping, transportation, labor, and/or field service charges.

Operational painted or finished hardware component finishes are warranted against peeling only for a period of one year. All other components of the door and hardware system are warranted against defects in material and/or workmanship for a period of one year from the shipment date. No other warranties are expressed or implied by Hörmann, nor shall they extend beyond stated time periods. Dark colors are not recommended where the door is exposed to direct sunlight for extended periods, such as a southern to western exposure. It is applied to the door sections over the baked-on polyester finish coat of the pre-painted steel from which the sections are made. The film integrity of the paint finish will be covered for a period of one (1) year and covers issues that arise related to paint adhesion. This may be evidenced by cracking or peeling of the paint finish to the extent that a significant amount of the underlying color is visible upon ordinary outdoor visual observation. Minor cracks, scratches or abrasions to the painted surface not related to adhesion are not considered defects. Custom matched touch-up paint is delivered with each door to address such imperfections in the field. The color will also be covered for fading beyond 85% of the original gloss.
